Company Summary

Şehzade Enerji Üretim Ticaret Sanayi Anonim Şirketi (became a joint stock company with the change in its legal form in 2014), one of the companies in A.I.S group started its commercial life in 2011 and produces electricity from wind energy. The other shareholder of Company, 45% of the shares of which belongs to our group through Eurowind Holdings (Malta), is GNCR Holding A.Ş., one of the few holding companies in Turkey, engaged in mobile life support services, mobile payment services, solid waste management, construction and solar energy. The Company's sole area of activity is to produce renewable, clean, environmentally friendly electricity from wind energy based on Amasya wind park. The company has a wind power plant consisting of 14 Vestas brand state-of-the-art wind turbines, each with 3.3MW totalling 46.2MWm / 42MWe capacity on wings with a diameter of 126 meters, within the borders of Amasya Province Aydınoğlu Neighborhood and an annual total electricity energy of 149.000 MWh is produced and given to the system. Approximately 101.347 tons of CO2 per year meet the electricity needs of 46,000 dwellings. The EBRD-based long-term investment loan was used to finance the construction of the facility whose total investment value is €67 million.

Amasya WPP, built with the latest technology devices in the world, has been operating since 2016. In order to be able to increase the capacity of the wind power plant to 84 MWe installed capacity, an application was made to the Energy Market Supervisory Board and the application is expected to be approved soon. After the commissioning of capacity increase, which will require additional investment of about €50 million, the annual turnover of the company is expected to increase to €18 million. In addition, an EIA report has been prepared for the area where the capacity will increase for the total of 366.3 MWm capacity, and our application was accepted by the relevant government agency.

In the near future, it is stipulated to invest in the subject wind power plant to raise the energy efficiency to a higher level and to generate electricity by keeping energy loss to a minimum.

The company does not have a subsidiary.

The company's total assets shown in its Balance Sheet are at the level of 204.431.000 TL as of the end of 2017.

Our Vision

Our company's main goal is generating clean electricity from wind power plant and helping development of Amasya.
